## Sinnet Court update

Thanks to DRARA and local residents for giving us the opportunity to host 'Film in the Court' back in September – a good time was had by all, including ourselves!

New residents arrived at Sinnet Court in September. Building on our experiences over the last 12 months we have revised our introduction procedure, stressing to all residents on arrival that they live in a residential area, and that inappropriate behaviour is not and will not be accepted.

Records show that false fire alarms are down considerably from last year. This is due to the penalty system which is being enforced by Sinnet Court staff and wardens, and to the students being more mindful.

Car parking in the local area is an ongoing issue, and we are still following the procedures outlined in previous DRARA newsletters. Of the 35 cars that have been reported to us to date only three have been traced to residents of Sinnet Court. We have reprimanded the individuals in question and the cars have not been seen again. I would like to encourage local residents to continue to call the Sinnet Court office to let us know about any cars that they believe to be our residents'.

Generally the number of calls we have received this academic year has dropped dramatically. So far we have received one noise complaint – we could not link this with any fault or specific room, but we sent a notice out to all residents of the block in question.

We look forward to working with DRARA in the future and arranging further events within Sinnet Court.

## Oxford Brookes Liaison

I recently attended meetings of Headington Residents and Oxford Brookes Liaison Committee. At the latter there was a lengthy discussion about students parking, which is always top of the agenda. I reported that windscreen wipers had been tampered with in Southfield and Divinity Roads.

Brookes in are successfully running buses collaboration with Stagecoach. There has been a 21% increase of passengers on the U5 (the Cowley Road bus) and 66% of this is due to residents. ## 1901 Census online

Since the 'Who do you think you are?' series on television, there has been an upsurge of interest in genealogy. Online at [www.ancestry.co.uk](http://www.ancestry.co.uk) it is now possible to search for people by name, approximate date of birth, and place of birth for the England or Wales censuses for every decade from 1851 until 1901.

New DRARA committee member Elizabeth Mills has gone one stage further – she is researching the names, origins, ages and occupations of all the residents of the DRARA area at the time of the 1901 census. She has discovered, for example, that the last houses in Divinity Road in March 1901 were numbers 88 and 89. Number 89 was occupied by Charles G Richards from West Lulworth, Dorset and his wife Hannah from Beaminster in the same county. Their children Harold, 6, and Hilda, 5, were born in Oxford.

And they had a general domestic servant living in – Maud Eustace, a local girl who was only 13. Mr Richards was the manager of a gentlemen's tailor and hosier.

Other 1901 DRARA residents included several butchers, many college servants, clergymen, clerks, cabinet makers, builders, a professional artist and a monumental sculptor.

Elizabeth's plan is to transcribe all the census information for the DRARA area and, in due course, put it on the DRARA website. Meanwhile, if you are keen to find out who lived in your house in 1901, she will be happy to look it up for you. ### '20's Plenty!'

### SS Mary & John churchyard

The restoration of the SS Mary & John churchyard continues! At the end of the summer we had to mount a massive clearance effort, both because of the rampant plant growth and to create access to the graves so that headstones could be tested for safety.

We are trying to encourage wildlife habitat while also providing pathways to the memorials that have an educational value – we are busy researching the considerable links with local history. People already frequently stop to read the display boards on the wildlife and local history. It is also a great joy when families feel able to return, having for years hesitated to visit graves.

The landscaping of the frontage onto Cowley Road will soon start in earnest, with a new path direct to

the north door of the church, more stepping stones to the sitting walls round the labyrinth, and new plants, trees and a wildflower meadow. A few old trees have to come down first, but we hope the new ones will grow quickly!

### **Parking**

The number of cars parked in local streets seems to rise every year, making it increasingly difficult for residents to find a space close to their house. Some have suggested that the introduction of a Residents' Parking Zone (RPZ) might be the solution. Last spring the County Council approved this idea, in principle, for local streets with the exact measures to be developed in consultation with residents. It is planned for some time in the period 2005/06 to 2010/11. It is not an easy option, however, because the Council's traffic consultants said in their report on local traffic issues that "the introduction of an RPZ would result in a potentially substantial loss in available parking, as the existing provision would need to be rationalised and footway parking would not be permitted." So the introduction of an RPZ is likely to make things worse rather than better. **Peter Coggins**

### **Celebratory Lighting**

You will have noticed that we have extended the celebratory lighting on Cowley Road this year. The East Area Parliament has funded additional lighting on The Plain, and, following last year's successful trial, provided more than 40 sets of window lighting free to Cowley Road businesses. We hope you will agree that this has enlivened Cowley Road!

However, we are chasing up the contractors on a number of issues (which I hope will be sorted by the time you read this). The lampost lights on Manzil Way were not secured properly, some lights are not working and others are on all day (they are meant to only come on when the street lights do).

### **Green Fair**

### **'East Oxford' poster**

### **Bingo Hall update**

The old Bingo Hall has been purchased. Cllrs Craig Simmons and Sid Phelps met up with the new owner, Mr Ali, and were rewarded with a behind-the-scenes tour of the amazing building. Much of the building has to be protected, but there is still potential to use it in a number of ways. The Council are in discussions with Mr Ali about possible community uses, and Mr Ali himself is keen to use the large downstairs hall for events and – eventually – restore the whole building to its former cinematic glory.

Sid and Craig got the impression that this was clearly a labour of love – Mr Ali has fond memories of sneaking into the cinema as a young boy and is a bit of a film buff. The East Area Parliament has asked to be kept up to date on progress. We are all obviously keen to maximise the community use of the venue, and Mr Ali, in turn, seems keen to work with us.

### **Cowley Road finished (almost)**

The Cowley Road works have kept Craig (with his County Councillor hat on) very busy this year, but we feel that his almost-daily site visits have helped to minimise problems.

We are pleased to report that, unlike Cornmarket Street, the Cowley Road works have been delivered on time and on budget. In general we are pleased with the results: wider pavements, more bikes racks, more bins, more trees and more benches. The 20mph zone – though more limited than we would have liked – is also welcome. However, there are inevitably some issues that need further work.

The County is now entering into a 6 month monitoring period, after which they are planning to do any necessary tweaks. The East Area Parliament has already received several detailed suggestions from one DRARA resident, which we are following up. You can rest assured that we are aware of the major outstanding problems: poor drainage where paving is incomplete or uneven, problems with signage etc. We are working hard with the County to address these and the East Area Parliament has offered more than £20,000 from its own limited budget to subsidise any additional work.

Our main concerns are the continued high speeds (buses and cars) and some of the 'pinch points', which are particularly affecting cyclists.

We are continuing to work with traders, City Works, Environmental Health, County Highways and Planning to establish a licensing regime for pavement use. The aim is to keep a two metre strip

of pavement clear for pedestrians but also allow, where space permits (e.g. opposite Manzil Way), for the controlled display of goods and outdoor seating for cafes in summer. We have also been working with City Works to keep rubbish (trade and domestic) off the pavements. There has been a definite improvement but several serial offenders remain, who we will be taking action against.

### Licensing (again)

The new licensing laws have now come into effect, and we are – as predicted – already getting complaints. We are assured that the information about licences granted will shortly be available on the City website, but officers are still overworked dealing with appeals, so realistically this is going to happen later rather than sooner. In the meantime, the best officer to contact to find out about specific premises is Lee Carter ([lcarter@oxford.gov.uk](mailto:lcarter@oxford.gov.uk)).

The new laws don't seem to take into account the fact that many licensed premises are in residential areas and thus '24 hour' drinking might be a little disruptive (to say the least).

If anyone has a complaint that they can relate to specific licensed premises, then please do write to the Licensing Department with details and send us a copy. The new laws do, in theory, make it easier to revoke licenses – though this has yet to be put to the test.
